**Updates:**

**1 . Ohio Board of Regents**

Corey Posey, representative from OBR: The OBR is in the process of Implementing TPA (Teacher Performance Assessment) spearheaded by Tom Bordenkircher

- TPA will be used with candidates that are graduating.
- Roll out is for the four colleges that are piloting the program
- Hopes is that the revised tasks and assessments will be released for Ohio use this year
- Major aspect of the revision is that the original five components of the teaching event will be scaled back to three.
- Embedded in the task is how a program helps high quality teaching

Remember this is a pilot and the hope is that as the pilot goes forward materials will be shared with other institutions Videotaping is an important element as a tool to ensure that candidates are qualified and meet the expectations for entry year teachers.

Corey was asked to share with us in September what OBR plans to do in the area of metrics and evaluation.

Mike Smith, who is involved in the metrics and program review processes, suggested that all committees provide an update in October. Update to include the work and the products that are being created. OAPCTE also would like to know: “Did the Chancellor make any recommendations to these committees?” An October meeting would include all faculty who want to and can come. May need a larger venue. An October 1<sup>st</sup> meeting would be sponsored by OACTE, not OAPCTE.
