Updates:

- **AICUO** (no report) Emily Tully

- **Ohio Board of Regents:** Wendy Adams
 1. Metrics Reporting System closed for reporters. Student teachers are still completing their surveys. Hope to have draft out to reporters on Monday. Reporters will be able to go out and see posted reports.
 2. Fall Program Proposals are still out to consultants. Hopefully, Monday or Tuesday feedback will be ready for those proposing programs.
 3. Spring 2015 Program Proposals are now open. Wendy is overseeing process. March 1, 2015 the window will close.
 4. edTPA working group is meeting today from 8 am – 5 pm. Question rose about human subjects review for edTPA. There is a WebEx meeting-taking place in January.
 5. US DOE regs are posted for public comment. Open until February 2, 2015. The regs can be found on the AACTE website.

- **edTPA Comments (from Standards Board)** Ted Zigler
 1. Teachers have questions about their role in the edTPA process
 2. Concern from OEA about the roll out and lack of cohesion. OEA is not supportive. RESA is similar. That may be a plus in favor of edTPA
 3. Hope to make the argument that this is a seamless formative process. Ed Standards Board heard that perspective.
 4. Some IHE's videotape, some schools do the videotape, others schools and still do not videotape.
 5. There is still a legislative process ahead of any requirement.
 6. TAC (Technical Advisory Committee) needs to check on this report.

- **Middle Childhood Test Comments**
 1. Concerns about the test scores as well as content.
 2. Questions raised again about grade bands for licensure
 3. A short term strategy is in place to solve problem with Pearson
 4. More middle school principals looking for AYA specialists in grade 8, especially math and science.

Yes, we should also have an OAPCTE response

- A survey has come out from NAICU regarding financial and human resource cost in relation to the regs
- Concerns about privacy issues are raised from private institutions.
- AICUO will respond to the federal regs
- The OAPCTE response needs to be in concert with AICUO. We also need to submit individual responses.
- Mark believes that the responses should not just be generic. Elements of the response might be individualized.
- Mark will draft an OAPCTE response. Hope to have a draft ready for the January meeting.
- The question surfaced regarding our small programs raises some questions for the licensure areas that produce a small number of graduates.
- There seems to be a direct line back to federal loan concerns and loan default
- Need to consider the regulations simply point by point
- Present a possible alternate proposal
- Teacher Preparation supports assessment and accountability as long as a fair and equitable system is put in place for all programs that produce teachers, i.e., TfA.
- The response might need to consider Ohio's response to public school teachers in terms of salary and professional development expectations.
- **REMINDER:** Mark will get draft out to OAPCTE members prior to the January meeting. Mark will also send bullet points of the notes he took. Mark will include some thoughts about how individual institutions might respond.
- OCTEO Spring Update – proposals under consideration. Keynotes are booked.
- Rae White noted that the Southeast regional group meeting looked at assets of the Appalachia area. Powerful new book from the Battelle for Kids – ***The Best Teacher in You*** by Mike Thomas and a group
- **New Business**
 - **ETS:** Concerns have been raised about the ETS sites for those few licenses that require these tests
