- ODHE – Krista Maxson
 - Making progress about edTPA
 - Add on and Endorsements – CAEP not accepting
 - Ed Prep Metrics will be released tomorrow 2.15.2020
- Legislative Update Ann Shelly
 - Vouchers is the big issue.
 - HB 9 where voucher solution was tied on. Degree completion was there and also eligibility for ed choice. Currently now having house conference meetings. March is the deadline to make a decision.
 - SB 89 Senate version – change of ed choice with vocational ed.
 - Bill on School Start times – Senator Williams – research says if you start school later the student does better. Concerns were about about transportation.
 - HB 164 – Religious Expression – a lot of opinions have been shared. Much of the religious right in favor of it. The Left is not. There have been two hearings which might mean
 - Dyslexia bill – specifies the phonics course and two other content courses. The voucher bill has taken priority over everything else. Nothing has moved on this lately.
 - Day on the Square Discussion: Last year was late and became a problem and getting appointments. April 2nd is the proposed day in a room in the state house when the senate is in session. Invite senators interested in Teacher Prep with a specific topic to address with the invited Senators. HB 216 – How can we ensure programs are inclusive and meeting the needs without the constant change?

- Report on the meeting with NCTQ**

- Jim, Krista, Diana, and Julie attended the meeting with NCTQ. Jim did not get out of the meeting what they hoped which was supporting their work and helping them to move forward. What they heard was that their work is not seen as valid and their methodology is not seen as valid. They Google our websites and contact our students to send syllabi if they cannot get us to respond.

- School district acceptance of fee vouchers**

- Are you having trouble with fee waivers with local school districts? If so, how are dealing with this issue?
 - Senator Lenier – felt we EPPs need to be more proactive to help compensate cooperating teachers.
 - Legislation was passed that we could not pay teachers – mandated by the ethics commission.
 - Sally shared that Cincy school district do not want the fee waivers they want compensation. Came from the treasurers offices in the school district.
 - Fee waivers Based on the number of hours candidates in field placements – teacher can turn in the waiver for \$100.00.
 - Mike Smith shared that we need to engage p-16, SUED and OAPCTE to create a statement. Show the p-16 partners how the clinical model works for student teaching.

- The Reading Materials contracted for**

- The week after OCTEO – NCTQ offered their research on reading in the US. Making the case that reading improved because NCTQ placed pressure on EPPs to improve our reading instruction and had nothing about what we are doing only them. We wanted to pull together all the work we have done to share with our legislators to counter NCTQ to share with legislators. OAPCTE and SUED are contracting Dr. Jessica Mercerhill to pull these materials together. OAPCTE and SUED will share the cost of paying Dr. Mercerhill for her work. Make sure p12 literacy is included. If your institution is doing something unique that you can share send a few sentences to Jessica to include. The response will be showing what OHIO institutions are doing to improve reading. You can include OAE data from your programs to show how candidates are doing.
 - **Here's the questions to respond to for Jessica:**
 - **1. No more than 5 sentences explaining the program.**
 - **2. Do you have data on the effectiveness of the program? If so, please provide 1-2 "fast facts".**
 - **3. Who should be contacted should follow-up information be desired?**

- After we get these materials also share them with our Presidents and Provosts so they have this information to use in response to NCTQ.
- Be sure to share more in your local press about how we are working together with our partners will be a great benefit.
- Include all the great things that the state has done in reading in the last 10 years.

CAEP Advanced Program workshop

- Shared about the CAEP Advanced standards workshop last year. 60 people attended from across the state. Feedback was very positive. Asked about having a follow up meeting this spring. Bring the Accreditation Coordinators together this spring. Asked OAPCTE to allocate \$3,000.00 to support the event. Looking at a date in April at Ohio Dominican. This will be open to SUEd and they would pay a fee to cover lunch. \$17, 198.00 left in treasury

- Gap Grants
 - Request that we use for the Gap Grants
 - Materials will be sent to Julie that OACTE used.
 - Send Jim an email about proposals about how to use the funds.
- OACTE looking to raise the dues next year and should OACTE reduce dues to balance fees for OAPCTE members
- Host a meeting pertaining to accreditation issues specific to private colleges
- Other?
 - Consider reducing the dues for OAPCTE since we have a large amount in the treasury.
 - Discussed that changing the dues can be an issue with budgets at institutions.
 - Money to help kids to be able to attend Ed Rising.
 - OACTE will not fund the gap grants.
 - Dottie shared we need to look at a workshop on CAEP accreditation for private colleges. The CAEP conference is very expensive and the information gained from it is limited. Create a one day conference for the privates for each standard.
 - Ohio Dominican said they would be willing to host his conference.
 - September or October Meeting was discussed.
 - Jim asked us to reach an agreement to hold a CAEP workshop for Privates in the fall. Come back together in March and have an idea of funds needed and take action then.
- Fall OCTEO October 22-23, 2020 – Play note – Research and Materials about Differentiation in instruction, PBIS, etc, that are research-based. Material provided for everyone.
