- Old Business/Updates
 - OAPCTE Response to Teacher Education Proposal from Feds Mark Meyers
 - Cannot vote on the proposal will do at the next meeting
 - Source or information for each EPP's response is AACTE website
 - Will work on notes for OAPCTE response
 - AACTE has rich resources to aid institutions in their individual responses
 - · Generating responses from each institution is important
 - There is a value in shaping the response "as your own" prior to sending off to the U. S. Department of Education
 - We need to focus on the substantive issues related to the new regulations
 - Mark has not seen a draft response from SUED or AICUO. Mark will check with both groups to ask them to share drafts
 - The advocacy committee of OACTE is working on a draft response.
 - Katie suggested that the AACTE website is the best place to find substantive resources to support each institution's response. There is an AACTE webinar from December that can be accessed.
 - There are a number of articles and other media responses available on the AACTE that can help support the institutional response.
 - Reactions to the AACTE response led to a more intense discussion on data for the feds as well as here in the State of Ohio:
 - OAPCTE believes that accountability is valuable the method/s are the concern
 - We need to raise concern about data: how collected, what is done with the data, level of accuracy of data.
 - A longer discussion ensued regarding the use of value-added data in regard to our graduates both teachers and principals.
 - This year some noted a lack of guidance to help interpret the data. Last year, there was some guidance regarding the data.
 - Data is in the metrics report comes from ODE not OBR
 - There is no clear understanding of how the state is calculating scores.
 - Both OBR and ODE need to be in the room at the same time to answer questions at a Fall OCTEO session.
 - A session needs to be conducted related to understanding and responding to the value-added data
 - Sally asked that individuals forward the questions to her regarding these value-added data and the scoring that is being reported.
 - Rae raised the question of many others about the grading process in terms of accuracy, meaning, and interpretation. This data collection and reporting becomes more complex when put into the larger national picture of data from multiple states.
 - If participants have any other comments, those should be emailed directly to Mark Meyers.
