- ODE John Soloninka
 - o Introduced Tom McGee new licensure person to ODE.
 - New Information:
 - OAE Tests working with Pearson to create new P-5 test for elementary, ISE and Professional Knowledge. Send name and email of people interested in helping review tests. Send to John and he will send list to Pearson. Can either work on face to face meeting or survey. Meetings will be recruiting in September.
 - New 010 test for computer science test New computer science endorsement will use this test.
 - Creating School treasurer test
 - In place of HQT is now Properly Certified or Licensed Tests. School will have to report in the EMIS Reports. Will have to show grade levels and licensed areas. Schools have a tool kit to use.
 - Teacher Leader Toolkit If you have this program the toolkit will be available in September.
 - Teacher Leadership Summit At OSU and over 200 attended. Used these ideas to create a teacher engagement committee. Group will work with ODE for a June 2020 conference.

- ED Standards Board Appointed people who will be part of a subcommittee. OAPCTE and SUED had members appointed
- Social Emotional Learning Standards New k-12 standards were approved in June 2019 and are on the ODE website.

Tom McGee –

- Substitute teacher short and long term license are eliminated.
 Beginning July 2019 new substitute license for anyone who has a post-secondary degree.
 - Candidate needs to ask for BCII/FBI information to be sent forward to get the license.
- Temporary option for MCE one area ending June 30, 2019.
- Licensure code for the code of conduct issued 2008 State board looking to revise it.
- Addition of new Principle 9 Professional Conduct Technology.
 Addresses issue of the schools technology and use of technology outside of school.
 - Inappropriate use of technology in schools has increased each year. Let students know that as a teacher they will be a public member and you need be aware of how you present yourself on social media and everyone can see everything.
- Supplemental license any school can put the candidate in supplemental and have two years to complete the requirements. Can hold the license up to 3 years. MCE supplemental does have to take the reading test.

ODHE – Jessica Mercerhill

- November 8 Latino Education Summit at Kent State Going to have some information on trauma.
- Computer science endorsement state board authorized accepting application for computer science endorsement. Can be added to any standard license. Can add to new teachers and practicing teachers.
- Call for endorsement committees at the end of Spring –Jessica is going to send another call – Drama – Middle Childhood Generalist – 3 hour reading across to content course.
- Survey for program review deadlines- Will resend as there is some questions about having institutions get approvals all at one time. Watch for survey. If everything goes through at one time
- Paraprofessionals and Student teaching looked at procedurally for being paid while student teaching if they are in a classroom that is in the licensure area and can continue to have a paid job.
- Employer Survey struggle with getting a good response rate. EPPs still having trouble getting this information. State has discontinued the employer

- survey at the state level as the rate kept going down. EPPS can still use the survey questions. If you have trouble getting to the questions email Jessica.
- Performance based Assessment request made to allow institutions that use a national level exam to use this in place of the APK for these students – moving to state board subcommittee. This will still take some time.

Legislative Update

The Legislature has completed the budget after a delay. The Governor did veto the sections that would have removed the requirement that schools hire licensed teachers. OACTE, SUED, and OAPCTE were active in seeing that the Governor was requested to veto the section.

The summer recess is almost on us. Much will happen behind the scene before the House and Senate meet again. Note: The Issue of school funding will heat up again with the introduction of House Bill 305.

Budget Conference Committee Decided Fate Of Education Oversight Panel: The legislature will have one less joint committee this fall. The Joint Education Oversight Committee which was created in a prior budget (HB64, 131st General Assembly) to assist the legislature with education policy issues was eliminated in the final budget legislation.

The House and Senate will not be in session until September as lawmakers spend time in their districts.

ODE Partners With Browns On School Attendance; State Announces Community Learning Center Grant Winners...

The Department of Education has attracted some key teammates in its efforts to tackle chronic absenteeism.

ODE on Friday launched its Get 2 School, Stay in the Game! Initiative, a partnership with the Cleveland Browns Foundation and Proving Ground at Harvard University.

The effort is intended to connect participating districts with experts, materials and evaluation tools related to school attendance.

"The equation is quite simple," Cleveland Browns Owner Dee Haslam said in a statement. "The more a student attends school, the more prepared they are for future success beyond the classroom."

As part of the initiative, the partners have launched a <u>website</u> with resources available to all school districts.

Report Cards Top House Ed Committee's Fall Priorities

The House Primary & Secondary Education Committee will return to a well-worn topic of debate when it resumes meetings this fall. Chair Rep. Louis Blessing (R-Cincinnati) said he wants the panel to re-examine the report card system the state uses to assign grades to schools and districts. The lawmaker said he has been in discussion with committee members Rep. Don Jones (R-Freeport) and Rep. Susan Manchester (R-Lakeview) about tackling the issue after summer break. The pair could use legislation (HB591, 132nd General Assembly) on the topic introduced by former Rep. Mike Duffey last session as a jumping-off point, Rep. Blessing said.

Senate Education Committee Chair Sen. Peggy Lehner (R-Kettering) has put addressing the state's system for intervening at poorly performing school districts at the top of her panel's to-do list. The lawmaker said the upper chamber may use a House-passed bill (HB 154) on the topic as a starting point but will likely transition to a substitute version with similarities to a proposed Senate budget amendment. Rep. Blessing said while the Senate's changes may lead to some disappointment among House members, he expects the lower chamber to support the final product to begin the move away from the current academic

distress commission system. "To get some relief, any relief, I think that will win the day," he said.
