• **ODE –**

- Sophie Hubble is the associate director in office of licensure at ODE
- All universities have a licensure officer who signs off on license. If you need help Sophie can help with this process.
- P-5 license test is working to move forward with Pearson. Working with their staff. If you have staff interested in working on the test for APK and Content for P-5. Also working on ISE p-5 as well.
- Moving forward with computer science test. Meeting with faculty in October. Hoping to have test available in December. Computer science license and the endorsement.
- Send list of those interested in helping to John. Send your name and email and then you
 will have to complete and online application.
- Spring 2020 is the first time the p-5 license can be issued for those programs that have converted to the new license.
- No later than fall 2020 you must have your p-5 program offered for freshmen education majors.
- The e-signature signer will check that candidate has met all requirements before they sign and send request for license.

O ODHE -

Jessica Mercerhill

- Need faculty to volunteer for standards committees for endorsements:
 - Drama/Theater
 - ECIS
 - Media Arts
- Three Credit hour across the curriculum for reading core Need faculty to help
- Commitment for committees allows faculty to decide how they want to work together. One in person meeting and then the rest is remotely.
- Heading to CAEP con and will ask why some spas are breaking away from CAEP
- SPAs are not required for Ohio Ohio has full state review or limited state review only.
 - Check CAEP website to see which SPAs are still part of CAEP
 - If SPAs are no longer around is there any changes in the cost for state review? Bundling all your reviews at one time this can be a way to save some money.

- If your SPA approval goes over the state approval you can do limited state review.
- edTPA Request national scored can be used for the APK if institutions are using edTPA.
 edTPA will not be required state wide. Cut score will be set at state level once a decision is made about the use of edTPA score in place of APK.

• Legislative Update

- Legislature is back in session.
- Gun control, reproductive rights are some of the topics on the table.
- Senate Education committee been dealing with HB 154 the academic distress. There is a new bill has is different than HB 154.
- Several people have resigned from the house and the senate and is an ongoing issue.
- Instead of the academic distress committee they would be creating a different committee to review.
- State report card came out. There is a study committee to review the state report card. Demaria felt it was a good report card. Most every school improved this year. There are 3 in academic distress and trying to figure out what to do with the districts.
- Pending:
 - HB 9 student degree completion and gen ed requirements. Will need to figure out how to be competitive. In Senate Higher ed committee.
 - HB 322 Ohio residency Program. Removal of the performance assessment is on the table. School districts find it expensive and annoying.
 - If this is gone then higher ed will have to find a different way to evaluate graduates are impacting students to have data for CAEP.
 - Has not been moved to committee yet.
 - Go to the Ohio House and type in HB 322
 - HB 305 create a new state funding system for schools.
 - College students to be allowed to think for themselves bills from the house and the senate.
 - Another bill Require high schools to have a valedictorian and salutatorian.
 - A bill requiring a public audit of state institutions.
 - Health education standards are in the house and senate.
 - HB 90 Bill on Education of the unborn.
