o ODE –

- Updates to the code of professional conduct Draft approved at the state board. Will update the website.

 - Jim shared that he viewed the list that is on the agenda for the state board and saw that the first 27 were people having their license revoked. This should be something to share. Use of the ABC Conduct sheets would be good to use with candidates.

- Introduced Krista Maxson Vice Chancellor of P-16 Initiatives
- Metrics reporting announcement went out Go in now to make sure programs are listed correctly and let MRS admin now
- CAEPCon and the advanced standards. Information presented was different than in the
 past. Information for Advanced Standards for Ohio are what you are to link to not what
 CAEP said at CAEPCon. Use the list on the ODHE website to link to. Link directly to
 the EdPRep Website.
- Performance Based Assessment edTPA will be discussed Monday. At subcommittee
 Monday. The committee discusses one month and vote the next. This would then go to
 the state board.
- 4/5 endorsement available until EPPs decide to close them out. Run as long as you have the resources and want to run the program.
- Is there guidance for the state for taking PD credit and using it for graduate credit equivalent? There is not expectation that this will happen but you need to make sure it meets the course requirements. Just be cautious.
- School districts provided PD credit to faculty from on-line programs where there is scripted credit from school not accredited by the state of Ohio. Working on guidance for on-line programs credits being offered by programs not accredited by the state.
- HLC and the p-5 change. Jessica will get clarification on how to handle.

Legislative Update

Ann Shelly

- Legislature is getting ready to campaign so they want to
- SB 40 /- University 9s Act Higher education is not being good and are not allowing opening statements and allowing their views (not true) but the legislature thinks this is the case. Brenner thinks higher education is a liberal conspiracy.

- HB 165 and SB 121 Health education standards bills in Senate and House. These were sent to the education committee. SB 121 keeps that you can approve venereal disease. Also reproductive health and abortion as well.
- HB 322 Eliminates the assessment and limit RESA to two years. NO appropriations for the RESA Program. Don Jones is the acting chair. No awareness of how higher education accreditation is tied to use of this assessment.
 - Change coming from superintendents that feels this is time consuming and expensive and they have the OTES that can be used.
 - Candidates feel they just went the edTPA and now they have to do RESA and it is redundant.
- HB336 Reinstate joint education oversight committee Huge number of cosponsors.
- HB 305 Fund Schools getting into hearings now in finance committee much the committee had to do.
- SB 154 Distressed School Bill working behind the scenes and have not come to compromise. Would get rid of distressed schools. Governor would not sign anything that did not have early distress in the bill.
