- Updates from ODE, ODHE and our legislative update will be provided at the joint meeting with SUED – Started at 2:05 and ended at 2:53PM
- o ODE:
  - Tom McGee Licensure:
    - New Testing for P5 Starting this spring and is 001, 090 and?
    - New Test for P5 a year from now
    - ISE OAE 001, 013, 090
  - Resident Educator up for review
    - Language changes
  - Dual license programs for MCE and ISE
    - Approved by educator standards board so far.
  - P5 and computer license, drama theatre, and media arts endorsement in the law. Language change was changed for the superintendent's license as well.
  - Brain Roget:
    - ODE and ODHE, Ed Strategies group and A group from Texas
      - Strengthen Ohio Pathways for HS Mathematics
        - Junior-Senior Year and CCP and College
        - Three Pathways now at Universities
        - Advisory group involved

- Looking at Algebra or an equivalent as the law requires students to complete algebra.
- What is the mathematics high school students need? This is a question that will be addressed.

- Sherry Birchem:
  - How to support districts to select high quality curriculum materials and for students to be able to have easy access to them.
    - Helping with the selection and support of the use of the materials once they are selected. What are concerns with materials? What works? What does not work? Would like support for higher ed.
  - Teacher Leader Toolkit written by a group of teacher leaders.
- Teacher Leader Liaison Group 50 teachers identified
  - Train teachers to be ODEs voice in the field.
  - Group meets in February and will be place for two years
- Teacher Leader Summit June 10 at the Ohio Union at OSU
  - If you know someone who would be a good speaker at the summit please let ODE know.
- Higher Ed to help identify replacement for the APK.
- OTES is being revised and updated pilot ongoing this year as Ohio Board has to approve the new framework by May 1.
- OTES and OPES has to align with the new teacher evaluation system. Working to make these align. The system will now be a holistic rating.

### o ODHE: Krista Maxson

- Resolution passed A nationally recognized assessment must pass the APK.
  Would like input from HE what the criteria must look like to choose this assessment. If you would contact Krista if you would like to help.
  - This will be implemented July 1<sup>st</sup>.
  - Would like help from SUED and OAPCTE to get help with the criteria for the nationally recognized.
- March 15<sup>th</sup> is when program reviews are due to ODHE.
- No timeline when the new program review online process will be ready.
- Metrics reports will be on the website at ODHE mid-February.

### o Legislation Update:

- Ann Shelly: Latest update sent out earlier.
  - Teacher Residency Program is stalled at the moment.
  - Teacher oversight committee stalled
  - Dyslexia screening is moving forward

- SB 102 Dyslexia Bill There is a substitute bill now Bill would require teacher who have not received training will be given training. Teacher Prep Programs must have training (at least two semesters) for k-6 and intervention specialist programs.
  - Not been passed out of house and senate yet.
- There will be a flurry of things happening because of the election year.
- Student Religious Expression Bill Teacher will have to believe the students statement as presented and not correct. Bill has passed the house and is in the senate.
- Draft Bill June 30, 2021 Each candidate will have to have instruction in computer science that relates to their licensure area. This will be an addition to program requirements.
- Student degree completion requirements is moving along in the legislation.
- Health education standards are stalled.
