Jim welcomed everyone and shared the May meeting will be remote and that the meeting was recorded. **Updates**

ODE – Tom McGee

- Offering temporary license from May to December 1st. Website updated for the various scenarios for when the temporary license offerings.
- If individuals passed the license but not the endorsement they can apply for the RE license and apply for the temporary for the endorsement.
- ODE will work with you and the graduates to find a pathway toward the license.
- Once the students has the one year they can pay for the 4 year in 20-21.
- Will license for all programs? License will be for their program for example if you are ECIS you would get the license for the area as the temporary.
- The application is \$40.00 for the temporary license and it is one application for the program area and endorsements.
- Licensure at ODE is running at full capacity and license are being processed in two to three days. All are working from home but are working at full capacity.
- If getting P-3 and are dong 4/5 this summer can they apply for the p-5? They would need to apply for the program they are finishing so if P-3 student needs to apply for the p-3 and then apply for 4/5 after completing and passing test.
- Temporary one year license will count for the RE. Candidates can start the RE program with the temporary license.
- Does not anticipate a long wait for license approval. Usually 5-7 business days in the summer. May be a little longer depending on the how the summer plays out with COVID.
- \$40.00 would include the license and endorsement.
- Waiting on the rule to be approved to get the temporary P-5 license. Waiting for the state board meeting in May. Hope that in early June for the P-5 license to start issuing.

ODHE – Krista Maxson

- Pk-3 and 4/5 can they apply for the P-5? Students will apply for the P-3 and 4/5 since these are they programs they were completing.
- edTPA is in the process of being approved. Students who want to use for the APK it will not be able to be used until July 1, 2020.
- Clinical hours for summer Amendment Webpage about guidance for clinical hours. Not requiring 50% completed Leaving it to the institutions to make the decisions.

- Score for edTPA recommendation cut scores are awaiting approval. Will share after it is approved.
- Several things awaiting to be approved.
- Questions about CCP.
- Worked with Dottie Erb and ? on a survey about completion of clinical with 50% threshold or better.
- Candidate can do an alternative experience for completing the 50 hours. There is guidance through ODHE on how to handle. However, it is up to the Institution to decide how this is going to work.
- SPA or not to SPA committee meeting. If you could send Krista an email if you are able to work in this committee.
- Advanced program and endorsement document CAEP does not want to review the endorsements. Endorsements are state review only. What do we need to know that the endorsement programs are good programs?
- Program reviews for spring have not started on these program reviews yet. Krista will get to these soon.
- Once program is approved you will get a letter of approval.
