### **Updates**

#### O ODE -

### **Tom McGee**

- One year temporary license are in effect.
  - Dual license and provisional 4/5 Apply for temporary one year then there should be a section for the endorsements and students should click to add. Tom will check that this is working. Students can go back in to apply for the endorsement for the one-year temporary if they have already applied for another one-year temporary license.
    - All license areas ever offered are on the site.
    - They have issued over 500 temporary licenses to date.
  - Is the temporary license open to all or those just graduation? If the person has met all the requirements and have not passed the test they can apply for the one year temporary. They do not have to be only a 2020 graduate.
- PK5 license have been available May 5<sup>th</sup> and people are applying for them.
- License code field for Pk3 is 71 when PK5 license is it still 71? Tom will check if the number is different.

#### o ODHE –

#### Krista Maxson

- edTPA has been approved
  - Cut scores for edTPA: 13 scoring rubric 37, 13 world languages rubric 32, 18 scoring rubrics 44
  - edTPA not implemented until July 1 so students cannot use this as the APK score
    if applying prior to July 1.
- Thanked Jim for his work as OAPCTE President!
- SPA or Not SPA committee:
  - Shared the committee members Thank you for your service.
  - Revamping program review process.
  - Biggest concern the SPAs have not been working in the best interest of EPPs.
  - CCGS –working with them as an advisory group for both Public and Privates.
     CCEPP and then faculty panels who would review SPA content. Krista shared the possible process of how this group would work.

- Group working on the process for limited and full state review process as well.
   2500 programs to review that have to be reviewed every 7 years.
- Once the proposal is ready they want consensus before it moves forward.
- Spring program reviews are on hold until the new process is in place. The fall reviews will probably deferred as well until the new process is in place and there is a hiring freeze to hire people to review.
- Krista wants the input about the program review process individual and dual programs.
- Those submitting October program reviews should wait.
