### **Updates**

#### ODE –

#### Tom McGee

- Licenses are still available for the temporary licensure Early November or December 1<sup>st</sup> to apply for license. This gives students more time to get OAE tests completed due to COVID-19.
- OAC Code 2305 Changes to administrative specialist just offering license without the specialist fields. Those in programs will be able to complete as they
- 3301 Resident educator license Create P5 with dual ISE license New license MCE and AYA with dual licensure with ISE. They will be in the Portal when they are approved programs then we will make them available.
- 11 candidates for Ohio Teacher of the Year on the website.
- P5 licensure exam originally to be out in 8/2021. Expected to be out in September 2021.
- Roll out of teacher evaluation system OTES 2.0 Those already evaluator will take an
  updated training. New trainers can take training at Ed Service Centers All are online.
- Some schools not allowing student teachers, field experience students in to their schools. What is ODE doing to help to address this? Need something said from the state level to let schools know we can offer help virtually if not face-to-face. Tom will pass the message along.
- The dual option with ISE is a new change will not change the K-12 ISE.
- Malone starting the P5 and want to know when
- ODE is accepting the edTPA score if passing then can count for the APK test. There is a place on registration that students can mark to have score sent to ODE

#### ODHE-

#### Krista Maxson

- Program Review SPA or Not to SPA group
  - There will be faculty panels instead of consultants
  - Institution submit all programs at one time working with CAEP on this schedule. Would like 4 programs submitting their proposals in a term.

- P5 developing and common elements report will be reviewed once and then the components specific to individual programs sent to committee.
- New MCE, AYA, P5 details released in the Spring
- Fall Review- Hybrid reviewed by faculty panels for new programs and programs needing to be reviewed.
- By law P5 must be up and running fall 2020 and you would submit the program when your programs are up for review.

#### ODHE COVID Guidance Link:

• Survey at the end of the term and EPPs will need to share how they handled clinical experience with students.

## Program Approvals-

- Institutions will only send one approval letter for all programs when the IHE goes through approval instead of a letter for each program approval.
- Annual Fee for program approval
  - Asked Julie to write to Krista an email about the interest an annual fee for program approvals. Once a fee schedule has been determined it will be sent to the group for approval.
  - IHEs asks that the fee not go over what is normally paid.
- Question from Paula White, OWU, any guidance regarding the completion of fall clinical experiences (both field and student teaching). Does OAPCTE know whether similar adjustments which were made in the spring, will be made again this fall? If a college student request to work/participate only in an online format for their clinical experience, will EPPs be able to indicate that the student has successfully passed the clinical experience?
- Can ODHE help with schools that are not accepting field placements as well as helping provide teacher candidates with e-mails so that candidates can access the district's LMS?
- Update on grade banding for Intervention Specialist
  - Meeting with Deans Compact to put the standards together.
  - Plan for addressing Program Reviews and request for faculty to serve on panels.
    - Hired consultants for new programs so programs could start to be offered.
    - New system may have panels to be part of the review
      - Faculty will be on the panel that are part of the SPA associations.
      - Process will be peer-reviewed
    - If anyone is available to help with program review please contact Krista.
- When would you like the annual fee to start? This year would it be just the program submitting? Julie – start the fee structure until fall 2021 because IHE already have budgets for this academic year.

- Legislative Update was sent to OAPCTE on 8.7.2020
- Issues of racial justice and COVID
- Householder charged with major crimes has been removed as speaker of the house but not as part of the House of Representatives.
- Robert C new Speaker of the House
- Next House session is scheduled
- Senate meets on August 18<sup>th</sup>
- Occupational Licensing Bill
  - Nursing and Teaching were hit hardest by the COVID Pandemic

- HB 673 Business practices ED Prep program would have to provide students with alternative field experiences.
- Retention issue for 3<sup>rd</sup> grade guarantee. Without testing this will be a problem
- Guns in schools issue still on the table.
- DeWine said all children will be wearing masks in school.
- Limited Liability by the School District to the Student Teacher if they were to come down with COVID in the school. This will probably end up in the legislature.
